FINANCE

The accounts of the Association have been computerized. The income and expenditure statement is regularly placed in every Board Meeting. Financially, BAFFA has become healthier than previous year. BAFFA's financial position in the year ending on 30 June 2020, is shown as under:

Cash at Bank Tk.22,769,114.00, Cash in Hand Tk.3,27,139.00, FDR Tk. 10,26,08,000.00. Whereas in 2019, the FDR amount was Tk.8,90,01,861.00.

ARBITRATION

Arbitration Committee is well established and very active in assisting members in resolving issues relating to various disputes. The committee also received number of complaints from overseas Freight Associations and Agents on nonpayment of dues by BAFFA member's and vice versa. Five (5) meetings of the Arbitration Sub-Committee were held during the period 2019-2020, where a good number of cases were resolved.

PORTS (BIMAN & CAAB) AND CUSTOMS

The Port & Customs Sub-committee has operated tirelessly to facilitate all members and resolve all day to day issues. They have been very active and have held five (5) meetings of the Ports & Customs Sub-committee in Dhaka & Chattogram to resolve different problems with the Ports, Customs & Cargo Village.

The Government Affairs Sub-committee has had several meetings with different Ministries, Bangladesh Bank, National Board of Revenue, Civil Aviation Authority of Bangladesh (CAAB) and Port Authorities on different regularity issues relating to Freight Forwarding industry.
