



# REQUIREMENTS FOR MEMBERSHIP OF BAFFA

1.0	Duly filled-in BAFFA's prescribed Membership Application Form and applicant must be a prime shareholder.
2.0	Applicant's minimum educational qualification has to be Graduate with documentary evidence.
3.0	Attested copy of valid and up-to-date Trade License.
4.0	Attested copy of valid e-TIN Certificate and Income Tax Clearance Certificate.
5.0	Attested copy of Office Tenancy Agreement or Land Ownership document. Applicant's Office space area sha not be less than 600 (six hundred) sqft and must be well equipped with broadband internet connection an valid company's domain e-mail ID (not Yahoo Mail, Hotmail, Gmail etc).
6.0	Attested copy of valid Bank Solvency Certificate.
7.0	VAT Registration Certificate (13 digits).
8.0	Two (2) Copies of passport size photographs of each applicant and all other Proprietor/Partners/ Director along with present and permanent addresses of each.
9.0	List of key personnel (appointed staffs) of the company along with their designations and cell phone numbers. Number of staffs of the applicant company must be not less than six (6) persons.
10.0	Copies of National ID Card or valid Passport of Proprietor/Partners/ Directors.
11.0	The Proprietor, or the Managing Partner, or the Managing Director/Director of the company seeking BAFF membership must have cumulative working experience in the Freight Forwarding Industry for at least ten (10 years. No Objection Certificate (NOC) from the previous organization (if any) is necessary. (Copy/copies of experience certificate(s) from employer(s) must be attached with the Application Form, when applying for BAFFA membership).
12.0	Attested copies of the following documents must be attached with the filled-in New Membership Application Form:

13.0	Business Paid up-capital of the company not less than Tk.5,00,000.00 (Taka five lacs) for Local Company an Tk.50,00,000.00 (Taka fifty lacs) for Joint Venture Company.
14.0	Prescribed Declaration and Undertaking to be submitted on a Tk.300.00 non-judicial stamp duly sealed signed and notarized by a Notary Public. (Declaration & Undertaking must be signed by the Chairman or the Managing Director for a Limited Company, the Managing Partner for a Partnership Firm and the Proprietor for a Proprietorship Firm with official stamp and notarized by a Notary Public.
15.0	The Proposer and the Seconder have to be valid Members of the Association (BAFFA) and the proposing seconding signatories must be the principal nominee to the Association from the respective Firm/Company

	Additional requirements for Joint Venture Company:						
	16.2.1 The Principal Applicant must be the local shareholder (Bangladeshi national) of the partnership, or the joint venture;						
	16.2.2 The Principal Applicant must have work experience of 10 (ten) years;						
	16.2.3 The hired shareholder, Managing Director, Country Manager/CFO, COO, or any other equivaler employee must be employed from the country of the partner company, not from any third country;						
	16.2.4 Financially well-off/sound and experienced foreign freight forwarding companies can only invest in the freight forwarding sector as a joint venture partner, or in a partnership with a listed company of Bangladesh Freight Forwarders Association (BAFFA);						
	16.2.5 In case of formation of a joint venture, or a partnership company, between a BAFFA member comparant and a foreign freight forwarding company, to conduct freight forwarding business, the paid up capit of the partnership, or the joint venture must not be less than one million United States Dollars, and must be a compulsory cash investment by the foreign partner/company through fund transfer from their home country, this amount cannot be paid through a Bank Guarantee. Documentary evidence of transfer of required fund must be attached with the application of BAFFA membership;						
	16.2.6 The origin of the investment must be from the country of the foreign company concerned and in the concerned must provide the encashment certificate from the concerned Bank with endorsement Bangladesh Bank.						

#### **NOTE:**

- New Membership Fees shall be paid by "Bankers Pay Order" in favor of "Bangladesh Freight Forwarders Association".
- However, the President of BAFFA, subject to the recommendation of Membership Sub-committee, and/or the BOD of BAFFA reserves the absolute right, on their sole discretion, to relaxing the condition in case of an experienced and deserving applicant in the opinion of the management.
